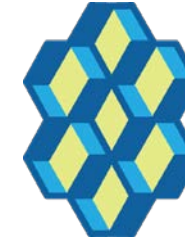

Applicants must have, and realistically allocate, sufficient expertise, supports, and dedication to complete the program.
